Subject: Observations made by the Inspection Committee during their visit of Rawal Institute of Engineering And Technology, Faridabad and directions by the Inspection Board for granting extension/continuation of provisional affiliation for existing course(s) for the session 2024-25.

1. Observations of Inspection Committee:-

It is stated that based on the physical inspection performed by inspection committee on dated. 15.04.2024 and documents submitted by the Institute following are the observations/suggestions by the Inspection Committee:-

- 1.1 Institute must comply with the observations conveyed to the Institute in AY 2023-24 which yet not complied by the Institute till now such as:-
 - External academic audit needs to be initiated.
 - Salary to faculty and staff to be provided as per AICTE/UGC norms.
 - Cadre ration of faculty should be maintained as per AICTE/UGC norms.
- 1.2 Institute should submit fire safety certificate issued by the competent authority of fire dept.

2. Directions by the Inspection Board :-

- 2.1 The Institute must comply the observations/suggestions mentioned by the respective Inspection Committee during the Physical Inspection before the commencement of the academic programmes for AY 2024-25. The compliance of the same must be submitted in the O/o Dean Institutions in the due time.
- 2.2 The Institute should maintain the Faculty Students Ratio and Cadre Ratio as per AICTE/UGC/University norms. The Institute must appoint the deficit faculty members as per AICTE/UGC qualification and norms before the commencement of the academic programmes. During the selection procedure of the faculty members, the Institute is advised to follow the Guidelines already been issued vide letter no. JCBUST/A&R/2022-23/1064 dated 04.08.2022 by the University.
- 2.3 The Institute is advised to initiate the process of reduction in intake/closure of the academic programmes in which the admissions are below 10% of the sanctioned intake consistently in last three years.

Institute must submit the compliance of 1 & 2 as mentioned above before the commencement of academic session.
